Land Acquisition: 333 acres preserved in 2009; 7,677 acres preserved to date. The Catawba Lands Conservancy permanently protects land and natural resources to benefit the public. The Conservancy balances the growth of our communities with the protection of open meadows, hardwood forests, working farms, bogs and marshes, streams, ponds, historical landmarks, and wildlife. Many of our protected properties are designated natural heritage sites where biologists have identified uncommon natural communities. Safeguarding the region's water supply and protecting the integrity of riparian buffers is another focal point for the Conservancy.

4b (Code: ) (Expenses \$ 748,688. including grants of \$ 0.) (Revenue \$ 720,081.)

The Carolina Thread Trail: A unique 15-county collaboration that will connect communities and conserve land through a network of conservation corridors and trails developed through locally designed plans. This long term project under the Conservancy's leadership will permanently protect this region's history, beauty, and diversity, while conserving local lands and providing a broad range of community benefits. The Thread will link more than two million citizens with hundreds of miles of conservation lands and pedestrian and bicycle trails that wind through fifteen counties in North and South Carolina, connecting points of regional significance. There are multiple benefits including economic development, conservation of land, enhancement of water quality, cleaner air, alternative transportation, and healthy recreation activity for all regional citizens, all of which translate to enhanced quality of life. The Thread will be freely accessible to everyone. At the end of 2009, there were 537 planned trail miles and 43 built trail miles.

Land Stewardship, Outreach Education, Administrative, and Fundraising: CLC carefully stewards and manages land to ensure natural systems are maintained or enhanced for future generations. Because we conserve land in perpetuity, we have the responsibility to make sure each property's special natural features remain intact. This is done through annual monitoring of each conservation easement and fee property, preparing written monitoring reports, and maintaining strong relationships with landowners. During 2009, there were 2800 hours of Stewardship Monitoring visits to our properties. The Conservancy's Stewardship and Legal Defense Fund is integral in our ability to permanently steward these lands. The Conservancy also educates the public on the benefits of land conservation through newsletters, e-alerts, volunteers, and traveling exhibit materials. In 2009, Conservancy staff spoke with more than 1,600 persons through outreach speeches, contacted 258 prospective landowners, worked with 350 volunteers, and hosted 1,182 people on our properties.
